Dear members,

My name is Connie Purchase and the intent of this letter is to ask for your consideration to allow me to serve as a director of the ACDHA.

My husband, Dennis, and I live on a farm in North West Iowa. Our present 4-legged family consists of 10 horses (9 Creams), goats, cats and dogs. Add in some feathered friends (chickens and ducks) and you have the whole crew. My husband is a building contractor while I run a recordkeeping service for livestock operations.

About 1995 I first heard about American Creams. I researched the breed and I WAS HOOKED. I was able to purchase my first boys (Ben and Jerry) from Don Johnson in 2002. "The Boys" were all I had hoped for and more. I was so enthralled with the Creams that I knew I wanted to expand to breeding. In 2004 I bought my first girls, Baskin Robbin and Wells Blue Bunny. Then I raised Breyers and Edy. (Yep, we do love our ice cream here). And finally, I was able to add Sandy to the herd. At present I am leasing 2 additional mares for breeding purposes. Three babies are due in June and July, and yes there are still ice cream names available. My boys are geldings, and all of my horses both ride and drive. They have been in parades, on trail rides, in driving competitions, and on exhibit at state and county fairs. My most recent addition was one of the "rescue horses". He was the aged gelding in very poor health. Wendell Lupkes called him "a real project". A local horse breeder practicing for a wagon train was killed Wednesday after she was thrown from the cart being pulled by her horse. Donna Popovich-Miller, 54, was driving the single-axle cart on Beyers Lane at about 12:15 p.m. when the accident occurred, said Nevada County Sheriff's Lt. Rich Fevinger. She was reportedly training the horse to walk over plywood when it spooked, throwing her from the cart. Her husband reportedly heard the horse running away and found Popovich-Miller unconscious and not breathing in the driveway. She reportedly sustained head trauma and was pronounced dead at the scene.

Betty has been started under saddle - she's been ridden in the arena and out on the trail a few times, but should have some more mileage put on her even though we have never had an incident with her. She'd make a great



trail horse for someone who wants a calmer mount. Betty has been bred this spring to our stud - unless she can be preg-checked and test negative, she MUST only go to a home that can provide for a foal next year.

American Cream Adoptions

The process of adopting the rescued American Creams is nearly complete. In total, there were fifteen horses that the ACDHA worked to adopt in conjunction with this rescue. One registered stallion, three tracking mares (one with foal by her side), two registered mares, and eight horses of unknown pedigree, age, and JEB and PSSM1 status.

We were notified around December 10th that we had become the adoptive agent for the horses, and on December 13th the first adoption letter was sent to the membership, both by email and by US Mail. That was the adoption letter for Max, which we could easily identify. Max was moved from the foster home on December 16th to help out Second Chance Ranch and Rescue, as they weren't set up to handle a stallion. We continued to send out adoption letters for horses as we could identify them. Keep in mind, at that point in time, the animals were at four different locations and fostered by people that knew nothing about the identifying traits of an American Cream. The ACDHA board decided the best way to properly adopt these horses was to DNA test all of them and test for JEB, PSSM1, and determine parentage, when needed. A package deal was made with Animal Genetics to test 12 horses for \$60 per head. Even after the testing, several horses did not have two parents identified, so per the by-laws, we sent DNA samples to Gus Cothran of Texas A&M to determine if they carried the Cream (champagne) gene and had only draft breeding.

Then the adoptions began to come together and it was time to see about arranging transportation if possible. We planned, and changed plans a few times, but on January 15th we moved the first group of horses from the foster homes to a volunteer near Lansing. By January 17th, the first two horses were on their way to their new home in Colorado. Then on January 20th, another five horses left for Iowa. The remaining young horses were tested, adoption letters sent, and the last youngster left the foster home on April 2nd.

There is only the young stallion left to place. He was DNA tested, but was not sired by Million Dollar Max, nor was he foaled by any of the mares from the rescue. He has been tested by Gus Cothran and has been determined to be of draft breeding. That adoption letter will be going out soon.

Special thanks also to Myron Karsten for transport and boarding, to Jeff Koenig for transport to Iowa, to Dan Zarske for boarding Max and assistance with identification. In addition, very special thanks to Suzanne and Pam of Second Chance Ranch and Rescue for finding a way to make this all work out.

Overall, this undertaking went better than expected, thanks to so many members, new members, and volunteers. However, we did lose two nice 2-year-old fillies that would have made one of the nicest team of mares a person could want. It just goes to show that no amount of effort can undo neglect once it gets bad enough.
