Letters of Intent



Hello. I am Karen Smith Watson, and I am running for the position of Director of the American Cream Draft Horse Association (ACDHA). I have been with the association for well over 35 years, starting out as an associate member and then becoming a full member and in 2009 a Life member. During my tenure with the association, I have served as Vice President and Director. I had the pleasure of *meeting* Karene Topp in person the year she stepped down as secretary and worked with Betsy Ziebell on the board for many years.

In 1989 to present, I was instrumental in creation of the breeding program of the American Cream Drafts for Colonial Williamsburg Foundation (CWF) for the Rare Breeds Program. In my personal breeding program and CWF, I was the first to show the cream drafts

at the Virginia State Fair, and several other venues with remarkable success and enthusiasm. Currently half owner of a cream draft and I am planning on expanding in the future.

In 1990, with the financial support of CWF, I became the founding editor of the American Cream Newsletter, which ran from 1991 to 2004. The intent of the newsletter was to keep members informed of the association news and nationwide happenings within the breed. Another goal was to record the history and preserve the history of early members and their stock. The current newsletter under the excellent editorship of Sue Engel, has now blossomed into a great periodical.

In 1996, Dr. Gus Cothran generously offers to blood typing/genetic testing, at no expense, for the association. It was a controversial idea but needed to be done to establish Creams as a genetically separate breed of draft horse, not merely a color breed. I strongly recommended members to submit samples and pulled many samples myself. As a result of this testing, it was established that American

Cream Drafts are genetically separate breed! It is our responsibility to continue preserving this amazing breed.

Over the years the members have spread American Cream breed recognition in many ways from a postage stamps, plastic model horses, books/magazines and hopefully the state horse of Iowa, all through their efforts. I would like to continue to promote the breed to every way possible, so that the American Cream Draft is recognized and appreciated for the unique breed they are. Many possibilities are there as continues to expand and promote the breed.

Our junior membership is our future and needs to be nurtured. Maggie Lupkes and Ben Corson are leading the way moving from junior to full members passing down the family's passion for the American Cream Drafts. The junior members are our future and our responsibility to educate, support and encourage them, so they can continue the legacy of the breed.

In 1994, the 50th anniversary of the association we had 34 full members and 17 associate members, last year 2023 we are up to 75 Full members, 27 Associate, 8 Junior and 21 Life members. My name is Tiffany Corson, and I would appreciate your consideration for Director of the American Cream Draft Horse Association Board for my second term.

Throughout my career, it has been my great honor to educate the public about the American Cream breed. I currently manage the breeding and horse business here at Corson Acres. I joined the ACDHA when I was 17 and have spent my life working and showing American Creams. In 1997, I was the first person to represent the American Cream breed at the Youth Hostel Program, where I met

trainers who taught me how to drive, train, and braid for show.

Since 2002, I have had the privilege of owning my own half-Cream gelding, Indy, who was born here at Corson Acres. Indy has become an ambassador for the American Cream breed. When I

went to college at Meredith Manor, Indy came with me, and since then, we have represented the Cream breed in eventing, dressage, hunter jumper, Pony Club, 4-H, and so much more. In 2008, Indy was used as a model for a Stone Horse at the Stone Horse County Fair, where he was the only half-Cream horse model they'd ever created. In 2017, Indy won the Half-Draft Horse Award at the Kentucky Horse Park, becoming the first American Cream cross to receive the title.

I manage the day-to-day operations of Corson's Creams, as well as the breeding, training, driving, and showing. Currently, Corson Creams has a breeding program where we breed both full American Creams and half Creams. We register the half Creams with the American Warmblood Society & Sport horse Registry. Last year, we had the very first ACDH born via embryo transfer. So far this year, we have had another successful embryo transfer foal born! We are expecting two more full Creams from surrogate mares, in addition to our two ACDH mares that are carrying their own foals. That makes five full creams due this year! We also have one half Cream due, and my Oldenburg mare is expecting a full Oldenburg foal. THAT is SEVEN foals this year! We are going to be so tired and extremely grateful.

My goal as the ACDHA Director is to help the ACDHA in any way necessary by continuing the work I do in service of the breed and the organization. I think my extensive knowledge would make me a perfect fit for the position, and I appreciate your consideration again.
